NOTE: A resolution has been prepared to acknowledge the following correction to Report CS-2010-041 – MPMP for 2009 which was received by Council by Resolution 2010-554.

Both changes affect the 2009 General Government measures, one is a correction of previously overstated "Total municipal operating costs", and the second is an increase to the "Operating costs for Governance and Corporate Management", due to a reallocation of the program support costs consistent with previous years. The net impact of these changes increased the efficiency measures as follows:
