PURPOSE AND FORMAT OF MEETING

The purpose of this meeting is to provide information to the public regarding the Rockfort Quarry proposal and to provide an opportunity for members of the public to express their comments and opinions. The Town of Caledon Council will not be taking a formal position on this application until February 2009, however public input and comments will be an important consideration.

BACKGROUND

James Dick Construction Limited (JDCL) applied to the Town of Caledon in 1998 for an Official Plan Amendment and Zoning By-law Amendment to permit a bedrock quarry of approximately 220 acres at the north-east corner of Olde Base Line Road and Winston Churchill Boulevard. JDCL has also applied to the Ministry of Natural Resources for a Category 2 license for a quarry below water table. These matters have all been referred to the Ontario Municipal Board.

In accordance with a process schedule approved by the Ontario Municipal Board, JDCL released revised technical studies in support of this proposal on July 31, 2008. Since that time, the Town of Caledon, Region of Peel and Credit Valley Conservation have been undertaking a technical peer review of these studies. The results of the initial agency technical peer reviews are to be released on November 21, 2008. After this Public Information Meeting, Credit Valley Conservation, the Town of Caledon and the Region of Peel will be taking formal positions with respect to this proposal in January, February and March, 2009 respectively. Public input received from this meeting and from earlier in the process will be an important consideration in determining the formal positions to be taken. The Ontario Municipal Board Hearing regarding this proposal is scheduled to commence on May 25, 2009.

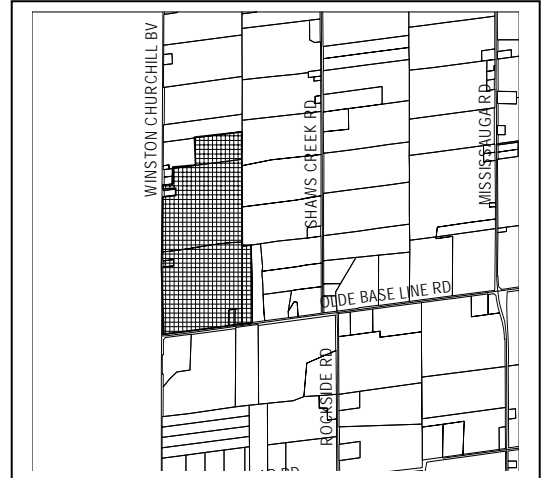
